NOW*), and money laundering (*Whitfield*). The Third Edition of **Understanding White Collar Crime** also discusses important federal circuit and district court cases in such areas as obstruction (*Quattrone*), mail fraud (*Rybicki*), securities fraud (*Martha Stewart*), and sentencing (various issues arising under *Booker*).
